Nuvision Credit Union ("Sponsor" or "Credit Union") will be sponsoring the Added Advantage Happy Birthday America Cash Giveaway ("Giveaway"). The Credit Union's business address is: 7812 Edinger Avenue, Huntington Beach, California 92647.

## **Giveaway Period**

The Giveaway begins at 12:00 AM Pacific Time ("PT") on Monday, May 11, 2026 and ends at 11:59 PM PT on Monday, June 22, 2026 ("Giveaway Period").

## **Eligibility**

Open to individuals who are 18 years of age or older at the time of entry and who are legal residents of the fifty (50) United States. Current or former employees, volunteers, officers, and directors of the Credit Union, and members of their immediate families (spouse, parents, children, siblings, and their respective spouses) and household members, are not eligible. Credit Union membership and Added Advantage Rewards Program ("AA Program") enrollment is not required to enter or win. Participation in the AA Program does not affect eligibility, odds of winning, or prize awards in this Giveaway.

## **How to Enter**

There are five (5) ways to enter. Limit one (1) entry per person, per week, regardless of method of entry. Entrants may enter once per week using one of the following methods. Entries not selected as winners will remain eligible for future drawings throughout the Giveaway Period.

A "week" is defined as Monday at 12:00 AM PT through Sunday at 11:59 PM PT.

### **1. Email**

### **Entry Conditions**

Entries must be received during the Giveaway Period and must comply with these Official Rules. Incomplete entries are void.

### **Selection of Winners and Prizes**

- **Weekly Drawings**

Weekly drawings will occur on Mondays beginning May 25, 2026, through June 15, 2026, and will include all eligible entries submitted during the immediately preceding entry week. Entries received prior to the first weekly drawing will roll into the first drawing. Each week, three (3) winners will be selected to receive:

- One (1) prize of \$1,300 (USD)
- One (1) prize of \$700 (USD)
- One (1) prize of: \$500 (USD)

- **Grand Prize Drawing**

### **Double Your Prize**

### **Prize Limitations and Taxes**

## **Charity Donation**

In addition to the individual cash prizes, Sponsor will make a charitable donation of two thousand five hundred dollars (US \$2,500) to Team Red, White & Blue (Team RWB). ## **Winner Notification**
