



2023 PFD Verification Sweepstakes Rules

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

2. HOW TO ENTER:

Beginning on January 17, 2023, ending on February 17, 2023, Nuvision Federal Credit Union members can enter into the 2023 PFD Verification Sweepstakes by email opt in, by visiting landing page and completing all information requested, or by opting in through a Nuvision member representative. Non-Alaska members (and non-members) may qualify by submitting an alternate entry (below), which must be received at Nuvision Alaska on or before February 17, 2023. You may enter only once. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.

3. ELIGIBILITY

Open to residents of all states, 18 years of age and older as of January 17, 2023, except for employees of Nuvision Federal Credit Union ("**Sponsor**"), their affiliates, subsidiaries, and agencies ("**Promotion Parties**"), and members of their immediate family or persons living in the same household. Void where prohibited.

4. DRAWING

A random drawing will be conducted on or about February 17, 2023, by Sponsor to select the winner from among all eligible entries received. Odds of winning depend on the number of entries received. Potential winner will be notified by email and must sign and return any required verification documents within fourteen (14) days of the date notice is sent or such other date set by Sponsor.
